Introduction

The CIB Board can have maximal 25 Members. Including the President, IPP (Immediate Past President) and other Officers.

According to the CIB Constitution maximal two members of the Board can be from the same country.

The (at present) eight CIB Regional Directors have a standing invitation to attend Board meetings as Guest, also if they are not Member of the Board.

Non-Board Members can be appointed by the new Board as Members of a Board Committee (PC: Programme Committee, AC: Administrative Committee, MCC: Marketing and Communications Committee, SCC: Student Chapters Committee). In that case they will have a standing invitation to attend Board Meetings as Guest.

All CIB Members have been invited to submit nominations for candidates for election into the 2016-2019 CIB Board.

Based on all nominations received the current CIB Board, as requested by the CIB Constitution, proposes the hereafter following candidates for election by the CIB Membership at the General Assembly meeting on May 30, 2016 in Tampere, Finland.

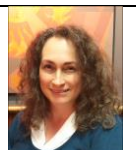
